



# STRIP-OFF

## PRODUCT DESCRIPTION

**STRIP-OFF** is an effective paint stripper gel, based on a combination of mild solvents and surfactants.

---

## APPLICATION

**STRIP-OFF** removes all 1 and 2 components varnishes and wall paints, both water-based and synthetic. Removes glue residues like carpet glue, glass fabric including wall paint, graffiti on bare concrete and brick and removes wax layers.

  - Long open time( up to 48 hours)

## OPERATING INSTRUCTIONS

Apply **STRIP-OFF** in a thick and even layer on the surface using a brush or roller and then leave for 30 minutes - 36 hours.  
At lower temperatures or thicker paintlayers leave for longer times and cover the **STRIP-OFF** with a plastic sheet.  
Remove the paintresidue with a spatula and filling knife and clean the surface with water under high pressure, 50 – 300 bar depending on the surface and paint residues. After cleaning rinse with clean tap-water. If neccasary repeat the procedure.

## APPLICATION CONDITIONS

**STRIP-OFF** can be used in all dry weather conditions. Temperatures lower than 10°C can slow the effectiveness of the product.

---

## THEORETICAL CONSUMPTION

Consumption is approx. 0,3 - 1 l/m<sup>2</sup>. Consumption is strongly dependent on the thickness and nature of the layers to be removed.
